Joined as a Lecturer in B.O. & Management on 15.06.1988 in a small rural college in the remote district, Purulia (Though Sri Pan secured 1st position in the panel) and devoted myself in the pursuit of higher education of the very backward region and community and gained respect among students, Teachers, staff & people of the region.

About 12 years ago I joined as Principal Gushkara Mahavidyalaya on 28.01.2005. Total experience as Principal – 11 years 7 months. At the time of my joining Gushkara Mahavidyalaya was an ill managed college and heterogeneous factors interacts behind it. The main business of the college, i.e. teaching-learning and evaluation of students was sidelined. College audit was pending for four years (now updated). A few classes were held for 3rd year students. Result of the University final examination was very poor. Attendance of students was meager. Attendance of staff was not regular in the true sense. Shortage of physical infrastructure was there.

My first and foremost attempt was to move the college in the right direction for which it was created i.e. proper arrangement of teaching-learning and evaluation of students with the help and assistance of a team consisting of Principal, Teachers, Staff, the G.B. and students. We get unexpected achievement in the followings: To instill the confidence among, the teacher, staff and students for holding and attending the classes regularly, maintaining discipline in the campus, green environment, scientific temperament, community feelings, good result in the University final examinations (high success rate has now become an usual outcome though large number of students are of 1st generation learners and belong to SC, ST and backward classes and Minority Community reside at **Jangalmahal** area of the district of Burdwan).

1st cycle accreditation of the college by the NAAC was done under the leadership of Dr. Pan in the year 2007 and accredited mark was B⁺. In the NAAC report able and dynamic leadership of Dr. Pan was mentioned. SSR for 2nd cycle accreditation had been submitted on 31.12.2015 and reports and other documents have been accepted by the NAAC. The Peer Team, NAAC will visit Gushkara Mahavidyalaya from 3rd October, 2016 to 5th October, 2016. College is expecting a good mark from the NAAC in the 2nd cycle accreditation.

During his tenure Dr. Pan with the financial assistance from State Govt., UGC and its own source has develop sound physical as well as academic infrastructure (new Library building, classrooms, galleries, five playgrounds, boundary walls, e-governance of Library and Office and state of the art laboratories of all depts.) All 17 academic departments are now connected with high speed internet facilities.
